Much like popular tax preparation software, it guides users through a series of questions to automatically generate New Mexico court forms. These self-guided interviews can be completed anytime, from anywhere.

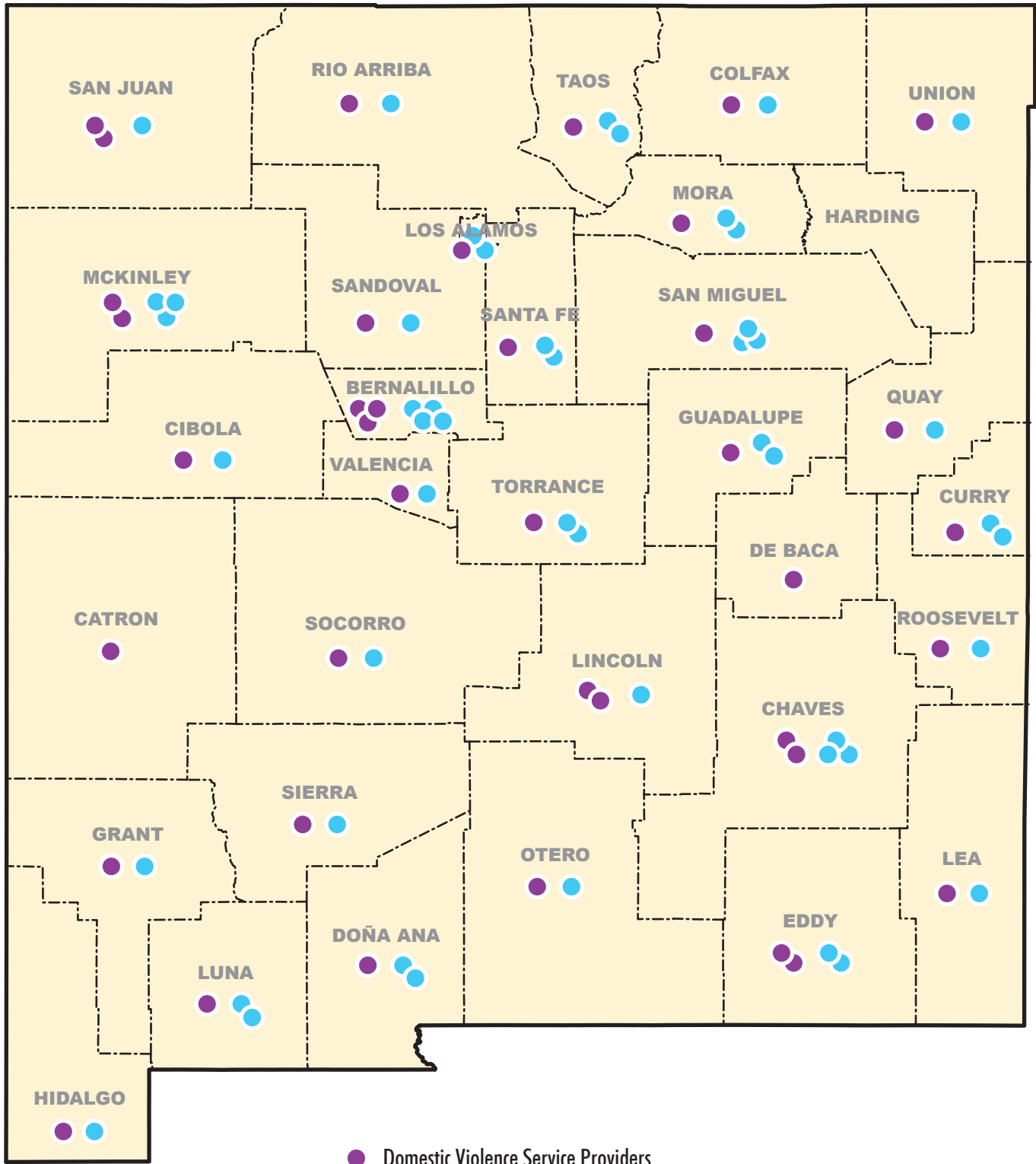
If the Petitioner cannot access the Petition online, they can go to the courthouse.
